(i) the 313,500,000 Units held directly by FCL Trust Holdings Pte Ltd ("FCLTHPL") (by virtue of their being the holding company and ultimate holding company of FCLTHPL, respectively); and

(ii) the 20,186,584 Units held directly by Frasers Centrepoint Asset Management Ltd. ("FCAML") (by virtue of their being the holding company and ultimate holding company of FCAML, respectively).
