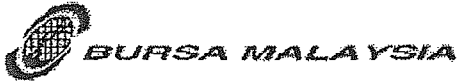

1. Production stoppage due to severe flood in Ayuthaya, Thailand

We wish to announce that the dairies product manufacturing facilities in Rojana Industrial Park, Ayuthaya, Thailand under F&N Dairies (Thailand) Limited, a wholly owned subsidiary, was flooded this morning and has ceased production.

At this time it is not possible to assess the extent of the damage. The Group will provide an update on the effect of the flood after employees regain access to the plant and are able to carry out an assessment of the damage, lead times for obtaining replacement parts and components and repairs, and restoration of supplies.

Crisis management teams have been activated and Management's priority will be to ensure the continued safety of employees and to minimize disruptions to its customers.

2. Financial effect

The group has in place a Property All Risk and Business Interruption insurance cover in respect of its Thailand operations.
