On 11 September 2012, HIBV purchased 55,000 shares in the capital of Asia Pacific Breweries Limited ("APB") representing 0.02% of the total issued and paid share capital of APB, by way of open market purchases and married trades, at a price of S\$53.00 per APB share (excluding brokerage commission, clearing fees, stamp duties and goods and services tax).

As a result, HIBV's direct and deemed interest in APB has increased from 85.98% to 86.00%.
