Fraser & Neave Limited ("F&N") holds a 100% direct interest in FCL. FCL holds a 100% direct interest in each of Frasers Centrepoint Asset Management Ltd. ("FCAM") and FCL Trust Holdings Pte. Ltd. ("FCLT"). FCAM holds 23,892,544 units in FCT. FCLT holds 313,500,000 units in FCT.

On 18 December 2012, International Beverage Holdings Limited ("IBHL") transferred 412,423,822 ordinary shares in the capital of F&N (representing approximately 28.6% of F&N's issued share capital (less treasury shares)) to its wholly-owned subsidiary, IBIL, pursuant to an internal restructuring for accounting purposes. Therefore, IBIL has a deemed interest in the 337,392,544 units of FCT in which F&N has an interest.
