On 8 December 2021, Golden Capital (Singapore) Limited ("Golden Capital"), which had a 0.06% interest in ordinary shares in Thai Beverage Public Company Limited ("THBEV" and its shares, "THBEV Shares"), acquired 620,415,000 THBEV Shares from Maxtop Management Corp. ("Maxtop") and 833,335,000 THBEV Shares from Risen Mark Enterprise Ltd. ("Risen Mark"). Following this, Golden Capital has an aggregate interest of 1,470,000,000 THBEV Shares (5.85%), Maxtop has an aggregate interest of 3,706,627,762 THBEV Shares (14.76%) and Risen Mark ceased to hold any interest in THBEV Shares.

Charoen Sirivadhanabhakdi and his spouse, Khunying Wanna Sirivadhanabhakdi, jointly hold a 100% direct interest in MM Group Limited, which owns a 100% direct interest in each of Maxtop, Golden Capital and Risen Mark.

Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi also jointly hold a 51% direct interest in Siriwana Co., Ltd. ("Siriwana"), which has an interest in 11,368,060,000 THBEV Shares (45.26%).

THBEV holds a 100% direct interest in International Beverage Holdings Limited, which in turns holds a 100% direct interest in InterBev Investment Limited ("IBIL"). IBIL has a direct interest of 28.41% in the shares of the Company.

Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all the shares in the Company in which IBIL has an interest.

TCC Assets Limited ("TCCA") has a direct interest of 59.10% in the shares of the Company. Each of Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi owns 50% of the issued share capital of TCCA, and is therefore deemed to be interested in all of the shares in the Company in which TCCA has an interest.
